- Development of Contents for the new version of National Portal (National Portal Framework) based on the instructions of consultant to make it service oriented.
- Monitoring advance development lifecycle of the systems on the requirements of the systems.
- Capacity development of the systems' users designated for the implementation regarding the use and maintenance of the systems.
